2143 32nd Street

MOTION: TO APPROVE A MAP WAIVER TO WAIVE THE REQUIREMENTS FOR A TENTATIVE MAP FOR 2143 32ND STREET TO CONVERT 2 RESIDENTIAL UNITS TO CONDOMINIUMS WITH THE FOLLOWING FIVE STANDARD SET OF CONDITIONS AS APPLICABLE: HISTORIC SIDEWALK STAMPS AND SCORING BE PRESERVED, FIRST RIGHT OF REFUSAL FOR RENTERS, NEW AND APPROPRIATE LANDSCAPING AS NEEDED, ON-SITE PARKING BE MAXIMIZED, AND OPPOSITION TO THE EXEMPTION TO UNDERGROUND UTILITIES.

4094 Mississippi Street

MOTION: TO APPROVE THE TENTATIVE MAP FOR 4094 MISSISSIPPI STREET TO CONVERT 8 RESIDENTIAL UNITS TO CONDOMINIUMS WITH THE FOLLOWING FIVE STANDARD SET OF CONDITIONS AS APPLICABLE: HISTORIC SIDEWALK STAMPS AND SCORING BE PRESERVED, FIRST RIGHT OF REFUSAL FOR RENTERS, NEW AND APPROPRIATE LANDSCAPING AS NEEDED, ON-SITE PARKING BE MAXIMIZED, AND OPPOSITION TO THE EXEMPTION TO UNDERGROUND UTILITIES.

1732 Myrtle Avenue

MOTION: TO APPROVE THE MAP WAIVER FOR 1732 MYRTLE AVENUE TO CONVERT 4 RESIDENTIAL UNITS TO CONDOMINIUMS WITH THE FOLLOWING FIVE STANDARD SET OF CONDITIONS AS APPLICABLE: HISTORIC SIDEWALK STAMPS AND SCORING BE PRESERVED, FIRST RIGHT OF REFUSAL FOR RENTERS, NEW AND APPROPRIATE LANDSCAPING AS NEEDED, ON-SITE PARKING BE MAXIMIZED, AND OPPOSITION TO THE EXEMPTION TO UNDERGROUND UTILITIES.

(McGaughy/Westfall). Motion passed 12-0-0 as a consent item.

Action Items

Four-Way Stop Signs at the Intersection of 29th Street and Palm Avenue

James Longley said that the City reviewed the intersection of 29th Street and Palm Avenue for four-way stop signs. They did not approve the four-way stop, but neighbors overwhelmingly approved it. The Transportation Subcommittee unanimously approved the four-way stop signs. Judith O'Boyle submitted to the Secretary over 75 signatures in favor of the stop signs on behalf of the residents surrounding the intersection. Martin Kruming spoke in favor of the signs. His primary concern was that cars have been diverted from Redwood Street because of the four-way stop installed there. There are both more cars and speeding cars. He urged approval. Geoffrey McCloud spoke in approval of the signs. He said that the problem is especially bad around rush hour. Ozzie Gontang supported the signs. He asked that they be installed as temporary at the very minimum. He was hoping that it would be installed one intersection closer to 30th Street, but the City said that it would be too close to 30th. Clyde Hayden said that the cars are traveling fast through the intersection. He supported the signs. Louis Sangiolo said that there is a proliferation of stop signs in North Park and opposed the stop signs. He said the noise and pollution resulting from too many signs is problematic.

Longley said that the Transportation Subcommittee tries to discourage stop signs because everybody wants one. He said that stop signs are the cheapest form of traffic calming. Eighty percent of signs requested of the subcommittee do not get accepted. The signs at 29th and Palm have the greatest support from surrounding neighbors. All signs are installed as interim signs.

Redwood lost 1,000 cars per day and Palm gained 1,000 cars per day as a result of the stop signs installed at 29th and Redwood. O'Boyle said that the Transportation Subcommittee has been heavily attended by those on Palm Street. Richard Kurylo said that the Redwood stop sign was a mistake and should be removed. Longley said that the Palm Street residents want the stop sign regardless because of the problem with speeding cars. Keoni Rosa asked what the next intersection receiving a stop sign would be if we approved this one.

Robert White objected to the sign because he wonders if the problem has been reviewed holistically. He noticed that the problems began when the Redwood sign was installed. He said the major problem was at 28th & Palm. Perhaps there is a better location for stop signs. Longley said that an island (divider) is planned for 28th and Palm. It has yet to be installed. Maureen Westfall said that she agrees with the stop sign proposal. O'Boyle talked about all of the suggestions that have been made for that area. Christine Bianchi said that she almost hit somebody at the 29th and Palm intersection the other day. She said that people are traveling on Palm to bypass the signal at Redwood and 30th and the stop sign at Redwood and 29th. The signal is the problem.

MOTION: TO INSTALL AN INTERIM FOUR-WAY STOP SIGN AT THE INTERSECTION OF 29TH STREET AND PALM AVENUE.

(Longley/O'Boyle). Motion passed 10-2-0. Bubb and Kurylo voted in opposition.

Subcommittee Reports/Liaisons

Urban Design/Project Review Subcommittee

- The next meeting is August 30.
- Agenda items for the August 30 meeting include the Lafayette Hotel, a project near Paesano's, and the University Avenue Mobility Plan. The Transportation Subcommittee will look at the University Avenue plan as well.
- Richard Kurylo said that water backflow devices installed in the middle of sidewalks have become problematic. It would be ideal if the Urban Design/Project Review Subcommittee could review the item.

Public Facilities/Parks/Housing Subcommittee

- The City of San Diego presented a sewer project in Burlingame. A map of the project area was distributed. The project will occur from March to December, 2006. Construction times will be from 8:30 to 3:30. Street damage repair will cost about \$10million. Vicki Granowitz said that there is "redirection of flow" of sewer lines from canyons to streets.
- The District 3 sidewalk study was reviewed. Walking data was given to the City. They will make some maps and offer suggestions. The goal is to identify areas of concern. Grim Street is a problem when it rains.
- The parcel at Landis and ~~Ivy~~ Boundary is being reviewed as a possible public park.

Transportation Subcommittee

- Conformity of parking signs at the North Park Community Park was reviewed.
- A four-way stop at Granada and Thorn was on the agenda.
- Visibility issues at 32nd and Juniper were discussed.

- The divider at Palm and 28th is being reviewed.
- The intersection at Nile and Myrtle is being reviewed because of problems with speeding.

Public Relations

- Lan Bubb said that the August meeting was cancelled because of an event at the Lafayette Hotel.

Bylaws Subcommittee

- There was no meeting yet this month.

Community Planners Committee (CPC)

- The discussion about the Big Box Ordinance was delayed.
- The August meeting was cancelled.

North Park Redevelopment Project Area Committee (PAC)

- PAC liaison Roger Lewis was not present. James Longley reported.
- North Park Main Street made a quarterly report, which was very elaborate. The report was requested by the PAC because North Park Main Street is funded in part by redevelopment funds.
- The La Boheme project is moving forward. A “Resolution of Necessity” was passed by the City Council to have Rite Aid “relocated.” A La Boheme construction update is on the North Park Community Association and North Park Main Street websites.

Law Enforcement Committee

- Richard Kurylo read a report on behalf of Bertha Klan.
- The Police Storefront is looking for a new location. They have to be out of their present location by August 20. An architectural firm is moving into the old building. Mary Coats said that the Police Storefront may be located in the San Diego National Bank building. Ed LaValle can still be reached at the same phone number.
- Car thefts are down. In fact, all crime is down this month.
- At the August meeting, there will be a parking person available. The meeting will be at the Adult Center.

North Park Library Task Force

- No report.

Balboa Park Committee

- The golf course bathrooms on Pershing will be made ADA accessible.

Clean Needle Exchange Program

- A final report ~~will be presented at the Clean Needle Exchange meeting next month~~ is being worked on.

New Business

- Board members that are absent for the Planning Committee meeting can still report on the Subcommittees that they attended.
- The Public Relations Subcommittee will review the proposal to write a letter and send new membership forms to all people in the database. Beth Swersie with the North Park Community Association offered to have the letter and membership form on their website. The Public Relations Subcommittee will review this.

Future Agenda Items

The Lafayette Hotel and a Developer Impact Fee (DIF) presentation will be on future agendas.
