Treasurer's Report

The bank balance on January 31, 2006, was \$406.03. The cash balance on February 28, 2006, was also \$406.03. There was an outstanding debt of \$100.81 for Planning Committee brochures. A collection container was distributed around the room to solicit donations. A total of \$77 was collected.

Officials' Report

• Todd Gloria from U.S. Congressional District 53 (Congresswoman Susan Davis) distributed an e-newsletter sign-up sheet for *The Davis Dispatch*. There is a student art competition in D.C. Congresswoman Davis is looking for local students to participate. Call (619) 280-5353 for more information. The Neighborhood Day in Normal Heights was

- cancelled due to injury by Congresswoman Davis. Vicki Granowitz said that mail delivery has improved. An informal poll of attendees confirmed improved mail delivery.
- Kirsten Clemons from State Assembly District 76 (Assemblymember Lori Saldaña) reported that the State Assembly did not agree with the Governor on the proposed infrastructure bond, so it will not be on the June ballot. There was agreement on two smaller bonds: (1) a \$10.4 billion education bond and (2) a flood bond. April 7 is Emergency Preparedness Day. Clemons can be reached at (619) 645-3090.
- Monica Pelaez from City Council District 3 (Councilmember Toni Atkins) distributed the March 2006 edition of *The Toni Times*. A North Park Town Hall Meeting is scheduled for April 8. The budget process calendar for 2006-2007 is available. A citywide budget hearing is scheduled for April 26. Dedication of the North Park Parking Garage was February 15. The garage is now open. Rates are reasonable. Walgreens is now under construction at 32nd and University. It will be completed in 6-7 months, and will be open by Thanksgiving. The manager of the Walgreens project can be contacted at (619) 584-2858.
- Jason Weisz from State Senate District 39 (State Senator Christine Kehoe) distributed the March 2006 edition of *Kehoe's Corner*. The newsletter contains contact information and a legislative update. Senator Kehoe scored 100% from the California League of Conservation Voters based upon votes on important environmental bills during the 2005 legislative session. One of Senator Kehoe's environmental bills was SB 44, which would require cities and counties to add an air quality element to their general plans. The phone number for the San Diego office is (619) 645-3133.
- Dan McAllister, San Diego County Treasurer-Tax Collector, provided information about the recent reformatting of the property tax bill. It is now easier to read and understand. An insert with the tax bill features a pie chart showing where tax dollars go. Nearly 6,000 taxpayers were due property tax refunds of \$1.1 million. The list of refunds are listed on the County's website. Tax payments are due on April 10 and December 10. McAllister said that May 10 and November 10 might be better. Payment options would be ideal. For more information, call (877) 829-4732.
- Amy Benjamin from the Housing Commission discussed the Commission's FY 2007 Action Plan. This is the third year in the City's Five-Year (2005-2009) Consolidated Plan. The Action Plan serves as the planning and application tool for five formula-based federal housing and community development programs: Community Development Block Grant (CDBG), Home Investment Partnership Program, American Dream Downpayment Initiative, Emergency Shelter Grant, and Housing Opportunities for Person with AIDS. Public comment is sought up to the March 29 deadline. Shirley Reid with the City of San Diego gave a brief presentation on CDBG. It was cut 10 percent this year. There is no plan should the Bush administration cut CDBG even more severely.
- For the North Park Law Enforcement Committee report, John Stewart McGaughy announced that the Police Department and Police Historical Association are presenting the first annual "Cops and Rodders" car show on April 15 featuring vintage police vehicles. Bertha Klann said there has not been a Law Enforcement Committee meeting for several months. There are a number of "head shops" selling drug paraphernalia. A meeting tomorrow will address this issue.
- The North Park Project Area Committee (PAC) had elections in February. One of 3 community organization seats is still vacant. There was no PAC meeting this month.

TO CONDOMINIUMS WITH THE FOLLOWING 5 STANDARD SET OF CONDITIONS AS APPLICABLE: HISTORIC SIDEWALK STAMPS AND SCORING BE PRESERVED, FIRST RIGHT OF REFUSAL FOR RENTERS, NEW AND APPROPRIATE LANDSCAPING AS NEEDED, ON-SITE PARKING BE MAXIMIZED, AND OPPOSITION TO THE EXEMPTION TO UNDERGROUND UTILITIES. (O'Boyle/UD/PR Subcommittee). Motion passed 11-0-0 as a consent item.

4665 Louisiana St. (Project #86045)

Richard Kurylo opposed this project because he opposes the "condominiumization" of houses. Since so many houses have separate residences in their back yards, Kurylo feared that approval of this project would set a bad precedence leading to the conversion of nearly the entire neighborhood of North Park to condominiums, which is not an ideal land ownership model.

3521 Nile St. (Project #86347)

Richard Kurylo opposed this project because he opposes the "condominiumization" of houses. Since so many houses have separate residences in their back yards, Kurylo feared that approval of this project would set a bad precedence leading to the conversion of nearly the entire neighborhood of North Park to condominiums, which is not an ideal land ownership model.

4368 Ohio St. (Project #86838)

MOTION: APPROVE A TENTATIVE MAP TO CONVERT 7 EXISTING RESIDENTIAL UNITS AT 4368 OHIO ST. TO CONDOMINIUMS WITH THE FOLLOWING 5 STANDARD SET OF CONDITIONS AS APPLICABLE: HISTORIC SIDEWALK STAMPS AND SCORING BE PRESERVED, FIRST RIGHT OF REFUSAL FOR RENTERS, NEW AND APPROPRIATE LANDSCAPING AS NEEDED, ON-SITE PARKING BE MAXIMIZED, AND OPPOSITION TO THE EXEMPTION TO UNDERGROUND UTILITIES. (O'Boyle/UD/PR Subcommittee). Motion passed 11-0-0 as a consent item.

Action Items

4133 Florida St. (Project #89306)

This was a proposal for a Tentative Map to convert 7 existing residential units at 4133 Florida St. to condominium units. The UD/PR Subcommittee requested that the applicants provide 7 versus 6 non-tandem parking spaces. The presenter said that it was physically impossible to provide 7 non-tandem spaces. Including tandem spaces, there were 14 off-site parking spaces. Judith O'Boyle asked whether it might be possible to create fewer units so there is one non-tandem space per unit. The presenter said that the building has previously conforming rights regarding parking. Two of the 14 parking spaces are substandard.

MOTION: APPROVE A TENTATIVE MAP TO CONVERT 7 EXISTING RESIDENTIAL UNITS AT 4133 FLORIDA ST. TO CONDOMINIUMS BECAUSE PARKING IS ADEQUATE PER CITY REQUIREMENTS AND THERE IS A SURPLUS OF PARKING BY TODAY'S STANDARDS (TRANSIT AREA). THE FOLLOWING 5 STANDARD SET OF CONDITIONS APPLY: HISTORIC SIDEWALK STAMPS AND SCORING BE PRESERVED, FIRST RIGHT OF REFUSAL FOR RENTERS, NEW AND APPROPRIATE LANDSCAPING AS NEEDED, ON-SITE PARKING BE MAXIMIZED, AND OPPOSITION TO THE EXEMPTION TO UNDERGROUND UTILITIES.

(Franck/Rosa). Motion passed 6-5-0. McGaughy provided the tie-breaking vote.

3975 Mississippi St. (Project #67420)

Keoni Rosa recused himself, as he was involved with the project. This was a proposal for a Tentative Map to convert 8 existing residential units at 3975 Mississippi St. to condominium units. The UD/PR Subcommittee's support for the project was weak due to insufficient parking (Planning Committee's standard is one non-tandem parking space per unit). There are 5 parking spaces for 8 units, but this was the requirement when it was constructed in 1959. Zoning is MR-800B, and it is on a 7,000 sq. ft. lot, so more units (9 versus 8) could be built today if the building were razed. A new structure could have one more unit <u>AND</u> completely conform to the Planning Committee's parking standard. Several members complemented the project's design.

MOTION: APPROVE A TENTATIVE MAP TO CONVERT 8 EXISTING RESIDENTIAL UNITS AT 3975 MISSISSIPPI ST. TO CONDOMINIUMS WITH THE FOLLOWING 5 STANDARD SET OF CONDITIONS AS APPLICABLE: HISTORIC SIDEWALK STAMPS AND SCORING BE PRESERVED, FIRST RIGHT OF REFUSAL FOR RENTERS, NEW AND APPROPRIATE LANDSCAPING AS NEEDED, ON-SITE PARKING BE MAXIMIZED, AND OPPOSITION TO THE EXEMPTION TO UNDERGROUND UTILITIES. (Boyd/Westfall). Motion passed 10-2-0. McGaughy and Kurylo opposed.

Arbor Crest South – 3701 Florida St. (Project #90318)

This was a proposal for a Site Development Permit and Tentative Map to demolish existing buildings and construct 52 residential condominiums at 3701 Florida St. This is the second of two projects by the same presenters on Florida Street, just one block south of the Arbor Crest North proposal. Height and setback deviations were being sought. An affordable component would be included. Richard Kurylo opposed the project for a number of reasons: (1) it is too large for the residential area – a building of this size would be more appropriate for University Ave. or El Cajon Blvd.; (2) single-family homes would be destroyed, and the neighborhood should be preserving all the remaining single-family structures, as too many have been lost; (3) the architectural style is poor; and (4) this project will produce a canyon effect when coupled with the existing multi-story project across the street. Setback deviations are due to Fire Department requirements. All property has already been acquired. Vicki Granowitz appreciated the affordable housing component and said the area is presently blighted.

MOTION: APPROVE A SITE DEVELOPMENT PERMIT AND TENTATIVE MAP TO DEMOLISH EXISTING BUILDINGS AND CONSTRUCT 52 RESIDENTIAL CONDOMINIUMS AT 3701 FLORIDA ST. (O'Boyle/UD/PR Subcommittee). Motion passed 12-1-0. Kurylo opposed.

Subcommittee Reports/Liaisons

Urban Design/Project Review Subcommittee (UD/PR)

There will be fewer condo conversions in a month or two and greater emphasis will be given to Urban Design issues.

<u>Public Facilities/Parks/Housing (PF/P/H)</u> and North Park Maintenance Assessment District (MAD) The North Park MAD is working on re-balloting efforts. Mike Petrogeorge will continue to be the liaison to the MAD for the Planning Committee. The North Park MAD report will be early on the agenda.

Library Task Force

The Library Task Force held a public workshop on March 1. The location of the library at 31st and North Park Way versus 31st and University Ave. met with public approval. Attendees felt the architecture should reflect the style of the business district (especially Art Deco and mid-century) versus the residential areas (bungalows and river rock).

Balboa Park Committee

The Balboa Park Committee's subcommittee on Land Use & Policy is reviewing special events, which have become numerous in the park. Presently, people can drink alcohol in the center portion of the park from 8:00 a.m. to 8:00 p.m., but the Balboa Park Committee may change that. A parking management plan for Balboa Park may alter parking.
