A. North Park/Mid-City Regional Bike Corridor Project: Georgia and Meade Avenue Portion
(6:10 - 6:25 pm)

Danny Bay – Project Manager May 10 public meeting

Overview: targeted population is “interested but concerned” segment Presented roject goals

Updated map: Now segmented into smaller segments. Today presenting GeorgiaMeade segment.

Features: buffered bike lanes the length of Meade

Center turn lane removal. Recently done on Madison in NP.

Neighborhood traffic circles planned. 8 pedestrian ramps at each intersection, set back from street. Some bulbouts. New: Bendouts – bike lane runs through bumpout.

Raised crosswalks. Some bike boxes – painted areas in front of car stop line at intersections.

NP improvements along Meade:

Various improvements. NEW: traffic diversions taken out. Insufficient volume reduction.

Showed Georgia and Meade road crosssections.

Examples of configurations: FL & ECB. Bulbouts. Other intersections.

Parking assessment: highest impacts in major intersections / largest projects. Gave state code requirements for visibility at intersections. SANDAG identified cross streets for angled / headin

parking. (info to be posted on SANDAG website) Showed parking impacts by intersection

RV – bendout question (not clear)

EB – concerned on Georgia near Sprouts – impacted, could have angle / head in parking.

EB asked before – went back and studied – section too narrow for angled parking. EB disagreed.

EB – also MS, same thing. A. got map at ECB BIA meeting today.

VG. Agree with EB, need headin anywhere possible.

EB – (broader q, will follow up) PH – door hangers? No – better postcards for multifamily MS – safety concern about losing center turn lanes? No – Meade volume and width make unnecessary.

DG – concerned about process – 1 we're not hearing everyone's concerns, 2 no action towards motions by NPPC. A. Process – complete design & submit to City, final approval. Not needing / wanting to go to NPPC, motion. VG – SANDAG does what it wants – RV – we can still make motions.

B. Request for Letter of Support for June 5, 2016 Suja Rock 'n' roll San Diego Marathon & Half Marathon. (6:25 – 6:35 pm)

Change in course and finish line location.

NP course changes: less impact north of Univ., longer distance on Univ. BUT will reopen by 10:30AM. South of Univ.: 30th reopen by 10:30am; access options for residents 510:30am.

Questions & Comments RV-

30th st reopen? North end by 9, south by 10. Light shaded lines are alternate routes for marathon: will change periodically to help traffic.

Marathon; allows traffic to move through. Will switch runners between main course and alternate periodically. Further discussion about parking limitation and noticing. Marathon clears up on rolling basis.

EB – not into UH? No.

VG – residents can get in and out throughout the race? Yes. Will advise if will be a problem.

D. Request for Installation of a stop sign on Mission Ave at Meade Ave & Alabama St. Request through the alternative process. (6:30 – 6:50 pm)

Matthew Ramos, resident Mission Ave. Greater ROW problems with increased traffic. Mixed use neighborhood. Commuter traffic high. Geometry unique: 7 (?) feeders into intersection. Need stop sign. Witnessed road rage, dangerous situations for pedestrians, handicapped. 100% support in neighborhood.

Questions & Comments

Neighbor – has local childcare, parents supported stop sign.

Neighbor – works from home, constant stream of traffic and conflict.

PH – q. clarify sign location; have worked with traffic engineer.

EB – vcalm sign there? Yes but not helping. Doesn't do much, often broken.

EB – past opposition to angled parking.

RV – lot of history with this intersection. 20067 saw this. At the time, city didn't want to do stop sign so did vcalm sign. Supports sign.

RS – remembers previous work.

DG – walked the area, looks good idea. A. 100% support of neighbors.

DG – email from Sharon Nelson “Mission Ave intersects with Alabama. Meade is 1/2 block south of that intersection. Rather than Mission/AL, I would think the alleyway between FL/AL on Mission would be more appropriate place for a stop as there's a stop sign on Monroe where it intersects at Mission & is a diagonal street.”

MOTION: to approve a stop sign by the alternate process for Mission Ave in the northeastern direction at the intersection with the alley between Florida St and Alabama St. (Per City Engineer Filipe Zedda instruction on location of stop sign) Vidales/Bonn 700

VG- section 12.1 ref to Process 4 PDP for Enhancement Program may change: proposal to be considered April 19 NPPC to make Process 3. Wait to revise.

RV VG – discussion about process to get priority list.

RV – Section 124.

EB – disc in lieu fees – wanted to go to parking district.

RV – background on tables. Rec element already done – from draft March plan

VG – will add Redwood & 31st street. Item 23 on distributed table.

RS – Q. confirmed list is not already prioritized. A.

RV – correct. Explained function of spreadsheet. Discussion. Public – Dennis Campbell – asked for clarification of how to use.

VG – needs by Sunday April 17. Discussion of timing input for both tables

RS – clarify – Morley Field pool?

VG – included in larger pool project.

RV – explained IE list: all from different draft CP elements. Did major categories like Encanto plan. Highlighted different projects.

RS – Q1 – bike improvements – 3c Pershing – higher priority since SANDAG work coming?

RV – sugg read policy above items – language clarifies.

RS – Q2 – sustainability – 3 – Urban Forestry already has this?

RV – no; urban forest plan more comprehensive in geo area, scope.

MS – q. re roundabout at Upas & Pershing – not enough capacity?

EB – 1: parking district contract looking at improvements to Park / ECB / Normal.

Intersection improvements important. 2: sustainability

multiple listing and historic context high priority. 3:

high priority Teacher’s Annex/library. 4: Pub facilities meeting spaces.

DG – for board members only?

VG – yes. Discussion on input, past public participation:

RV PH VG. RS – need to have this done – already vetted for years.

EB – good to have generic goals. Discussion about logistics / next steps to / including NPPC meeting.
